



General Terms & Conditions

eight \$88,888 Giveaway (“Giveaway”)

Introduction

1. This Giveaway commences on 30 July 2026 12.01 am to 8 August 2026 8 pm (Singapore time), both dates inclusive (“**Giveaway Period**”).
2. This Giveaway will be governed by these standard terms and conditions (“**Terms**”). By participating in this Giveaway, you confirm that you have read and understood these Terms and that you agree to be bound by and to comply with these Terms. Non-compliance with or breach of any of the Terms may disqualify you, and any prize won by you may be forfeited, withheld, withdrawn or reclaimed.

Eligibility

3. To be eligible to participate in this Giveaway, you must be at least eighteen (18) years old and an eight customer, and not have any outstanding bills with StarHub Mobile Pte Ltd and/or its related corporation, eight Telecom Pte Ltd (collectively referred to as “**we**” or “**us**” or “**eight**”) during the Giveaway, at the time of the draw and at the time of the claim or use of the Prize.
4. Employees of StarHub Ltd and its related corporations, each of their immediate families, as well as StarHub’s commercial customers and bulk subscription customers, are not eligible to participate in this Giveaway.

Giveaway Mechanics

5. Further to clause 3 above, you will have to purchase any device ("**Purchased Item**") from eight during the Giveaway Period to qualify as an eligible Participant. Purchases can be made:
 - Online via the eight eShop;
 - In-person at any eight service centre; or
 - In-person at the eight Roadshow from 6 to 8 August 2026.

Each customer who fulfils clauses 3 and 5 shall be referred to as a "**Participant**".

6. You will automatically receive 1 chance to win for every Purchased Item.
7. A Participant in this Giveaway may only win 1 prize.
8. The winner(s) will be picked from the eligible Participants during the following event(s):
 - a. **For Grand Prize and 2nd– 3rd Tier Prizes:** Grand Draw on Saturday 8 August 2026 at Cineleisure from 8pm onwards (the "**Grand Draw Event**"); and

The above prizes are collectively referred to as the **"the Prize(s)"**.

10. The Prizes, or any part thereof, shall not be transferable, exchangeable, redeemable or substituted for cash or other benefits. In addition, eight makes no warranty whatsoever as to the Prizes, including without limitation, the availability, quality, and fitness for purpose, or the use or consumption thereof or any other implied terms or conditions with respect to the Prizes.

Special Conditions for Grand Prize and 3rd Tier Prizes

14. The Grand Prize comprises an **eight** mobile plan with a subscription fee of S\$18/month for a period of 1,296 months that can only be registered in the Winner's name, subject to these Terms.
15. The 3rd Tier Prizes each comprise an **eight** mobile plan with a subscription fee of S\$18/month for a period of 96 months that can only be registered in each Winner's name, subject to these Terms. The Grand Prize and 3rd Tier Prize mobile plans shall collectively be referred to as the "**Awarded Mobile Plans**".
16. For the avoidance of doubt, the Grand Prize and 3rd Tier Prizes exclude VAS.
17. The Winners of the Grand Prize and 3rd Tier Prizes will be able to port-in their existing mobile line from another telco to enjoy their Prizes.
18. We shall be entitled to terminate any Awarded Mobile Plans with immediate effect under the following circumstances:

 - b. the Winner becomes or threatens to become bankrupt or insolvent;

judicial manager or administrator is appointed over any of his assets;

 - f. either StarHub Mobile Pte Ltd or eight Telecom Pte. Ltd, enters into liquidation or compounds with its creditors generally or has a receiver appointed over all or a substantial part of its assets or suffers any execution over such assets; or
 - g. death of the Winner.
19. In the event that eight ceases to offer any mobile plan with a subscription fee of S\$18/month, we will replace the Awarded Mobile Plan with similar mobile plan.
20. The Awarded Mobile Plans cannot be transferred, migrated, or converted to mobile plans offered under the StarHub main brand or sub-brands (including giga!).
21. The prevailing eight Mobile Terms and Conditions that is published on <https://www.eight.com.sg/terms-conditions/>, Fair Use Policy, and relevant Critical Information Summary will apply to the Awarded Mobile Plans.

Special Conditions for 2nd Tier Prize

22. The 2nd Tier Prizes each comprise an **eight** broadband plan with a subscription fee of S\$31.80/month for a period of 96 months that can only be registered in the Winner's name and registered residential address, subject to these Terms.
23. Further to clause 20, each 2nd Tier Prize only includes:
 - a. Twice a year Internet Check;
 - b. Free NLT Service Activation;
 - c. Free ONT Device; and
 - d. Free ONT Installation.
24. The 2nd Tier Prize broadband plans shall collectively be referred to as the **"Awarded Broadband Plans"**.
25. We shall be entitled to terminate any Awarded Broadband Plans with immediate effect under the following circumstances:
 - a. the Winner terminates, deactivates, or suspends the Awarded Broadband Plan;
 - b. the registered address at which the Awarded Broadband Plan is provisioned has been reclassified as a non-residential premise by the relevant government authorities;
 - c. eight Telecom Pte. Ltd ceases its broadband business in Singapore;
 - d. eight Telecom Pte. Ltd, enters into liquidation or compounds with its creditors generally or has a receiver appointed over all or a substantial part of its assets or suffers any execution over such assets
 - e. the occurrence of at least one of the causes for termination set out in Clause 17.3 of the eight Home Internet General Terms &

- f. death of the Winner.
- 26. The Awarded Mobile Plans cannot be transferred, migrated, or converted to broadband plans offered under the StarHub main brand or sub-brands.
- 27. In the event that eight ceases to offer any broadband plan with a subscription fee of S\$31.80/month, we will replace the Awarded Broadband Plan with similar broadband plan.
- 28. The prevailing eight Home Internet General Terms & Conditions that is published on <https://www.eight.com.sg/terms-conditions/> (or such other URL as we may publish on the official eight website) and relevant Critical Information Summary will apply to the Awarded Broadband Plans.

Special Conditions for 4th Tier Prize

- 29. The 4th Tier Prizes each comprise \$288 worth of eight mobile credits that will be allocated to an account in the name of each Winner (the **"Awarded Mobile Credits"**).
- 30. The Awarded Mobile Credits can only be used to settle the Winner's monthly mobile bills with eight. Once the Awarded Mobile Credits are linked to the Winners' respective accounts with eight, the Awarded Mobile Credits will automatically be used to offset the Winners' monthly subscription fees in accordance with the applicable billing cycle until all of the Awarded Mobile Credits have been used.

31. Each Winner is responsible for keeping track of the remaining Awarded Mobile Credits in his or her account. eight will not alert any Winner when they have used up all of the Awarded Mobile Credit.
32. For the avoidance of doubt, the Winner will not be able to utilize the Awarded Mobile Credits if the Winner is not a subscriber of an active eight mobile plan. The Awarded Mobile Credits are not transferable, exchangeable, redeemable or substituted for cash or other benefits

Collection

33. Winners must present proof of identity (NRIC/FIN/Passport) and the original purchase receipt/order confirmation of the Purchased Item to claim their Prizes.

Such personal data may include without limitation your name, telephone number, email address, personal identification or passport number, as well as your image, picture, photographs or likeness. You confirm you have read and understood and that you agree to the eight Privacy Policy.
